Member has committed his property (described according to Exhibit A, attached - your TAX STATEMENT or Property Description) by execution of this agreement to Association (and subject to acceptance by Association) to include in pool leasing arrangements **for a period of three years from date**. Association will use its best efforts to negotiate a mineral lease for Member's land for development of Minerals for the best price and terms deemed available by Association on the date the lease is executed. Member warrants that the land committed is not leased and shall not during the term of the agreement be leased by Member without the consent and inclusion of Association. If you do not own your minerals or if they are leased, the Association is not responsible for curing title or securing the release. Evidence of this Agreement may be filed of record by Memorandum executed by the Association. Once negotiated, Member agrees to execute the Mineral Lease approved by Association. All Lease bonuses will be by two party checks which will be endorsed by Member at Lease execution.

Member shall pay a non-refundable initiation fee of FIFTY AND NO/100 (\$50.00) DOLLARS due upon return of this application, good for 3 years and annual dues of \$25.00 on the second and third anniversaries of Membership.

FEE OPTIONS (Please circle your choice): At lease signing, Member shall pay:

**A) 5% of the bonus OR B) 3% of any bonus negotiated and execute
an assignment to the HSLA of 3/4 of 1% ORRI**

Association shall not be responsible for post leasing representation for damages. In addition to lease negotiation, Member shall be entitled to online or email updated information regarding Haynesville Shale development in the area. Member shall be entitled to general Tax and Financial information as a part of Membership. **This Agreement is subject to all the terms and conditions published by Association in its Handbook for Members, which Member has been provided prior to signing.**
